**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY dated as of May 2, 2022 (this “**Release**”) is made by Wells Fargo Bank, National Association, as administrative agent (together with its successors and assigns in such capacity, the “**Administrative Agent**”), in favor of each of the entities set forth on Exhibit A hereto (collectively, the “**Grantors**”) in respect of that certain Intellectual Property Security Agreement dated as of November 1, 2019 (as amended, restated or otherwise modified from time to time, the “**IP Security Agreement**”) by and among the Administrative Agent and the Grantors and recorded with the United States Patent and Trademark Office on November 1, 2019 at Reel/Frame Nos. 050912/0857, 6785/0844, 6785/0854, 6785/0864 and 6785/0878. All capitalized terms used herein without definition shall have the meaning given in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement, the Grantors granted to the Administrative Agent a security interest in the Intellectual Property Collateral (as defined in the IP Security Agreement), including but not limited to the intellectual property listed on the attached Exhibit B.

WHEREAS, the Administrative Agent wishes to: (i) release and terminate all of its security interest in the Intellectual Property Collateral; (ii) restore all right, title and interest in and to the Intellectual Property Collateral to the applicable Grantors; and (iii) terminate any and all liens and encumbrances respecting the Intellectual Property Collateral under the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby (i) terminate the IP Security Agreement in its entirety (except for any definition incorporated by reference in this Release) and (ii) release and terminate its security interest in the Intellectual Property Collateral, including the intellectual property listed on the attached Exhibit B, and discharge, quit claim and relinquish unto the applicable Grantors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Intellectual Property Collateral, including the intellectual property set forth on Exhibit B hereto, together with the goodwill of the business symbolized thereby, and all proceeds and rights to proceeds associated therewith, under the IP Security Agreement.


The Administrative Agent authorizes the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release to reflect the release of security interests and reassignment of any interests with respect to the Intellectual Property Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the internal laws of the State of New York.
