Statement of Conversion

Pursuant to Wyo. Stat. § 17-26-101, this statement is provided in order to convert Visionary Communications, Inc., to a Wyoming limited liability company.

1. Visionary Communications, Inc., is a wholly owned subsidiary of Visionary Broadband Seller, Inc., a Wyoming corporation.
2. On January 25, 2022, the shareholders of Visionary Communications, Inc. unanimously voted and authorized its Chief Executive Officer, Brian Worthen, to convert to Visionary Communications LLC, a Wyoming limited liability company.
3. On January 25, 2022, the shareholders of Visionary Communications, Inc. also unanimously voted to exchange, on a one to one basis, all of their shares in Visionary Communications, Inc. with Visionary Broadband Seller, Inc. The exchange of shares resulted in Visionary Broadband Seller, Inc. becoming the sole shareholder of Visionary Communications, Inc.
4. Visionary Broadband Seller, Inc. is the sole shareholder of Visionary Communications, Inc.
5. The former name of the corporation is Visionary Communications, Inc.
6. Visionary Communications, Inc., was formed in the state of Wyoming.
7. Visionary Communications, Inc., was incorporated December 8, 1994.
8. Visionary Communications, Inc.'s Wyoming Secretary of State, Filing ID is 1994-000296266.
9. Visionary Communications, Inc.'s original incorporator was James L. Edwards.
10. Visionary Communications, Inc.'s conversion to a Wyoming limited liability company was adopted by unanimous vote by its shareholders on January 25, 2022.

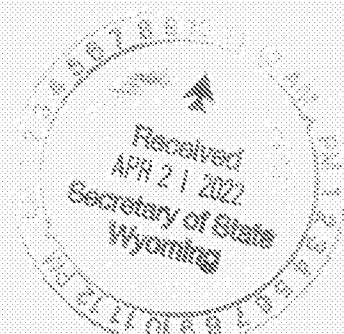

Articles of Organization Visionary Communications LLC

1. The name of the limited liability company is Visionary Communications LLC (hereinafter "Company").
2. The Company is being created to convert an existing Wyoming corporation to a limited liability company. A Statement of Conversion is included with these Articles of Organization.
3. The Company is a wholly owned subsidiary of Visionary Broadband Seller, Inc., a Wyoming corporation.
4. Visionary Broadband Seller, Inc. is the sole member of the Company.
5. On January 25, 2022, Visionary Communications, Inc., through its shareholders unanimously voted and authorized its Chief Executive Officer, Brian Worthen, to convert Visionary Communications, Inc. to the Company.
6. Pursuant to Wyo. Stat. § 17-25-101 et seq., the Company elects to be a statutory close limited liability company.
7. The Company's initial registered agent is Greg Worthen and the Company's initial registered office is located at 1001 South Douglas Highway, Suite 201, Gillette, Wyoming 82716. The registered agent's email address is: gworthen@visionarybroadband.com.
8. The Company's principal office is 1001 South Douglas Highway, Suite 201, Gillette, Wyoming 82716.
9. The Company's mailing address is 1001 South Douglas Highway, Suite 201, Gillette, Wyoming 82716.
10. The Company shall have a perpetual existence unless and until dissolved pursuant to the laws of the State of Wyoming or the Company's Operating Agreement then in effect.
11. The Company will operate as a Manager-Managed limited liability company. All company powers will be exercised by or under the authority of and the business and affairs of the Company

will be managed under the direction of the Manager. The initial Manager shall be Visionary Broadband Seller, Inc., the sole member of the Company, by and through Visionary Broadband Seller's President, Brian Worthen, or its successors and assigns. The Manager is vested with the authority to bind the Company and to act on behalf of the Company including, without limitation, by executing documents and agreements on the Company's behalf.

12. Membership Interests in Visionary Communications LLC will not be evidenced by certificates and the Company will not adopt a company seal.

13. The Company need not adopt an operating agreement unless the Members choose to adopt an operating agreement.

14. If a Membership Interest is: (i) subject to a charging order; or (ii) transferred due to divorce, bankruptcy, death or court order; such Membership Interest will be a "Transferee Interest". Subject to Wyo. Stat. §§ 17-29-502 and 17-29-504, the owner of a Transferee Interest shall not be entitled to: (A) participate in the management or conduct of the Company's activities or business; or (B) have access to records or other information concerning the Company's activities.

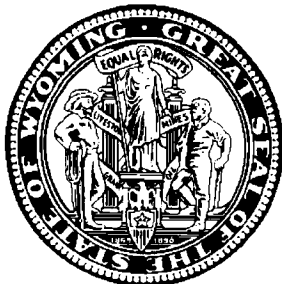
