COPYRIGHT TRANSFER AGREEMENT

Art. 1. Signing parties:

J12/2585/07.07.2016, with VAT no. 36289210, legally represented by Szabo Levente-Endre, manager, hereinafter **ASSIGNEE**;

Have concluded the following agreement in accordance with provisions of Law no. 8/1996 on copyright and related rights, in compliance with the following clauses:

Art. 2. The object of this agreement is the assignment of the patrimonial copyrights on the Dollarbird application by the Assignor against a payment of a price by the Assignee.

The references on the Dollarbird include:

Art. 3. The price

Any circumstance independent of the will of the contracting parties, occurred after the date of signing the contract and which prevents its execution is considered as force majeure and exonerates the party invoking it from liability.

Art. 8. Final provisions

The modification of this agreement can be made only in writing, with the agreement of both parties.

This contract represents the will of the parties and removes any verbal agreement between them, prior to or subsequent to its conclusion. This contract has been concluded in two copies, one for each party.
