**TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“**Termination and Release**”) dated as of February 22, 2022, is made by PORTMAN RIDGE FINANCE CORPORATION, a Delaware limited liability company (together with its successors and permitted assigns, the “**Purchaser**”) in favor of DOUGLAS MACHINES CORP. (“**Borrower**”)

WITNESSETH:

WHEREAS, Borrower entered into the Senior Subordinated Note Purchase and Security Agreement, dated as of April 6, 2012 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) in favor of the Purchaser, pursuant to which Borrower executed and delivered the Trademark Collateral Security Agreement and the Trademark Assignment of Security (together, the “**Trademark Security Agreement**”) assigning and granting a security interest to Purchaser in the Marks as defined therein, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor; and

WHEREAS, Borrower has requested that the Purchaser hereby terminate, release, and discharge fully its security interests in and liens on all right, such Marks (as defined in the Trademark Security Agreement), the goodwill of the business symbolized by the Marks, and the registrations and applications therefor, including those trademarks described on the attached Schedule I (collectively, the “**Collateral**”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Purchaser hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in the Borrower’s right, title and interest in, to and under the Collateral; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
