TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Termination and Release*”) is granted as of April 28, 2022 by **CITY NATIONAL BANK**, in its capacity as collateral agent for certain secured parties (in such capacity, and as assignee of Opus Bank, the “*Agent*”), in favor of **FLEXPRINT, LLC**, an Arizona limited liability company and **J.J.R. ENTERPRISES, INC.**, a California corporation (collectively, the “*Grantors*”).

WHEREAS, the Grantors executed and delivered that certain Trademark Security Agreement, dated as of December 13, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”), granting the Agent a security interest in and lien on the Trademark Collateral (as defined in the Grant), which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on December 13, 2017, at Reel 6227, Frame 0351;

WHEREAS, the Grantors have requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Trademark Collateral as herein provided; and

WHEREAS, the Grantors have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Trademark Collateral as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantors’ right, title and interest in, to and under (i) the Trademark Collateral, including without limitation those trademarks and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Trademark Collateral, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; and assigns, transfers and conveys to Grantors any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
