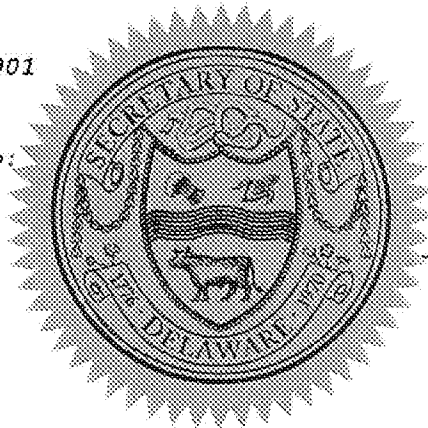

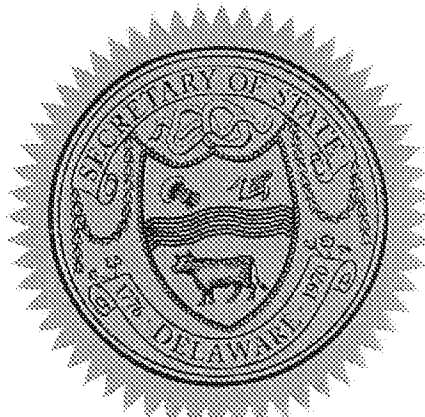

FROM A CORPORATION TO A LIMITED LIABILITY COMPANY
PURSUANT TO SECTION 18-214 OF THE LIMITED LIABILITY COMPANY ACT

- 1) The jurisdiction where Glu Mobile Inc., a Delaware corporation (the "*Corporation*"), first formed is the State of Delaware.
