CONFIRMATORY TRADEMARK ASSIGNMENT

THIS CONFIRMATORY TRADEMARK ASSIGNMENT ("Assignment") is made as of May 22, 2022, by and between **ALLIED DOMECQ SPIRITS & WINE LIMITED**, a private limited company incorporated in England and Wales (no. **00703977**) with registered offices at 20 Montford Place, Kennington, London, England, SE11 5DE, United Kingdom (the "Assignor"), and **TORMORE DISTILLERY LIMITED**, a private limited company incorporated in in Scotland (no. **SC688989**), whose registered office is located at Kilmalid, Stirling Road, Dumbarton, Scotland, G82 2SS, United Kingdom (the "Assignee").

WHEREAS, prior to the execution of this Assignment, Assignor and Assignee have executed an Agreement dated 26 April 2022, which provides, among other things, for the assignment of Assignor's Trademarks (as defined below) to Assignee, which assignment this Trademark Assignment is intended to confirm; and

WHEREAS, Assignor is the owner, on a worldwide basis, of all right, title and interest in and to the trademark, and the corresponding U.S. registration and/or application for registration of such trademark, set forth on Exhibit I (collectively, the "Trademark"), together with the goodwill of the business connected with and symbolized by the Trademark; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as set forth below.

1) Assignor hereby sells, assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademarks in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Trademark (including, without limitation, the right to renew any registrations included in the Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark, and any priority right that may arise from the Trademarks), together with all causes of action for any and all previously occurring infringements of the rights being assigned, and the right to receive and retain the proceeds to any such infringements, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

2) The parties hereby confirm that the Trademark listed on Exhibit I, including any pending applications to register, are being assigned as part of the sale of the entire business of Assignor to Assignee, or the portions of Assignor's business to which such Trademark pertain, as required by Section 10 of the Trademark Act, 15 U.S.C. § 1060.

3) Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office, and in any applicable jurisdictions outside the United States, to record the transfer to Assignee of all the U.S. registrations and/or applications for registration set forth on Exhibit 1, as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademark.

4) This Assignment shall be binding upon and inure to the benefit of Assignor and Assignee and their respective heirs, successors and assigns.


