GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS

THIS GRANT is made to secure the satisfactory performance and payment of all the Obligations of the Grantor, as such term is defined in that certain Security Agreement by, among others, the Grantor and the Grantee, dated as of the date first here written (as amended, restated, amended and restated, modified, extended and/or supplemented and in effect from time to time, the "Security Agreement"). Capitalized terms used in herein that are not otherwise defined shall have the same meaning as in the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern. This Grant and any claims, controversy,

dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Grant and the transactions contemplated hereby shall be and construed in accordance with and governed by the law of the Commonwealth of Massachusetts.


