**TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL  
PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (the “**Release**”) is made effective as of May 11, 2022, by and among PNC BANK, NATIONAL ASSOCIATION, as administrative agent for the Lenders referred to below (the “**Administrative Agent**”), and Guardian Medical Monitoring, LLC, a Michigan limited liability company (“**Pledgor**”).

WHEREAS, pursuant to that certain Acknowledgment of Security Interest in Intellectual Property dated as of November 23, 2021 (as amended, restated, modified or supplemented from time to time, the “**Acknowledgment Agreement**”), and pursuant to that Loan Agreement of even date therewith (the “**Loan Agreement**”), the Pledgor and other pledgors, granted to the Administrative Agent a security interest and lien on the Collateral (as defined in the Loan Agreement);

WHEREAS, pursuant to the Acknowledgment Agreement, the Pledgor granted to the Administrative Agent a security interest in the intellectual property listed on Schedule A attached hereto (the “**Patents, Trademarks and Copyrights**”);

WHEREAS, the Acknowledgment Agreement was recorded in the United States Patent and Trademark Office on November 29, 2021, at Reel 7508 / Frame 0697;

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest solely as to the Patents, Trademarks and Copyrights of Pledgor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Administrative Agent hereby agrees as follows:

1. **Definitions.** Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Acknowledgment Agreement or Loan Agreement, as applicable.

2. **Release.** The Administrative Agent hereby, for itself and on behalf of the Lenders under the Loan Agreement, hereby releases, discharges, terminates and cancels any and all right, title and interest in and to all Patents, Trademarks and Copyrights of Pledgor, including, without limitation, any security interest it may have in such Patents, Trademarks and Copyrights and the goodwill of the business connected with the use of, and symbolized by, such Patents, Trademarks and Copyrights, and retransfers and reassigns any and all right, title, and interest it may have in the foregoing without recourse to the Pledgor.

3. **Termination.** The Administrative Agent, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, hereby terminates and cancels the Acknowledgment Agreement solely as to Pledgor. The Acknowledgment Agreement otherwise remains in full force and effect as to any other pledgors to the Acknowledgement Agreement.

4. **Recordation.** The Administrative Agent hereby authorizes and requests the Pledgor and its successors, assigns or other legal representatives to file this Release with the United States Patent

and Trademark Office, at the sole expense of the Pledgor, to evidence and effectuate the release and termination of the Acknowledgment Agreement.

5. Further Assurances. At the request and expense of the Pledgor, the Administrative Agent hereby agrees to perform all other and further acts, and provide to the Pledgor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgor to retransfer and reassign any and all right, title and interest it may have in the above-referenced Patents, Trademarks and Copyrights without recourse to the Pledgor.
