**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this "*Termination and Release*") is granted as of March 28, 2022 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as agent for itself and certain other credit parties (in such capacity, the "*Grantee*"), in favor of **SAVE MART SUPERMARKETS LLC**, a California limited liability company (as successor by conversion to **SAVE MART SUPERMARKETS**, a California corporation) (the "*Grantor*").

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks, dated as of June 18, 2015 (the "*Grant*"), pursuant to which the Grantor granted to the Grantee a security interest in and lien on certain trademarks and trademark applications as described more fully therein (the "*Original Marks*"), which Grant was recorded with the United States Patent and Trademark Office ("*USPTO*") on June 19, 2015, at Reel 5556, Frame 0893;

WHEREAS, the Grantor executed and delivered a First Supplement to Trademark Security Agreement dated as of May 4, 2020 (the "*First Supplement*", and together with the Grant, collectively, the "*Trademark Security Agreement*"; all capitalized terms used but not defined herein shall have the meaning set forth in the Grant or the First Supplement, as applicable), pursuant to which the Grantor granted to the Grantee a security interest in and lien on certain trademarks and trademark applications as described more fully therein (the "*Supplement Marks*", and together with the Original Marks, collectively, the "*Marks*"), which First Supplement was recorded with the USPTO on May 5, 2020, at Reel 6930, Frame 0349;

WHEREAS, the Grantor has requested that the Grantee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Marks as herein provided; and

WHEREAS, the Grantor has requested that the Grantee provide a document suitable for recording with the USPTO to evidence the release of the Grantee's security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:


1. terminates the Trademark Security Agreement and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under (i) the Marks, including without limitation those trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications identified in Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) all goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same;
2. assigns, transfers and conveys to the Grantor any interest in all of the foregoing, including any lien and security interest thereof; and

3. authorizes and requests that this Termination and Release be recorded with the USPTO.
