FIRST SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This First Supplement to Trademark Security Agreement (this “*Supplement*”) is made as of May 11, 2022, by and between each of the signatories listed as grantor on the signature page hereto (each and together, jointly and severally, the “*Grantor*”), and **SILICON VALLEY BANK**, as Administrative Agent for itself and other secured parties (in such capacity, the “*Assignee*”).

WHEREAS, Grantor executed and delivered a Trademark Security Agreement, dated November 17, 2020 and recorded on November 17, 2020 at Reel 7108, Frame 0601 (as amended of record from time to time hereinafter, the “*Agreement*”) in favor of the Assignee, pursuant to which Grantor pledged, assigned and granted a security interest in certain Trademarks (as defined therein); and

WHEREAS, Grantor developed or acquired additional Trademarks and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Trademarks in favor of the Assignee.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. **Definitions**. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.
2. **Supplement to Schedule A**. Schedule A to the Agreement is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto.
3. **Miscellaneous**:
 - a. Except as provided herein, all terms and conditions of the Agreement remain in full force and effect. Grantor hereby ratifies, confirms and reaffirms all of the Obligations contained therein.
 - b. This Supplement and the Agreement cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.
 - c. THIS SUPPLEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE INTERNAL LAWS (AND NOT THE CONFLICT OF LAW RULES) OF THE STATE OF NEW YORK.
 - d. This Supplement may be executed by one or more of the parties to this Supplement on any number of separate counterparts, and all of said counterparts taken together shall be deemed to constitute one and the same instrument. Delivery of an executed signature page of this Supplement by electronic transmission shall be equally effective as delivery of an original executed counterpart hereof.
