TERMINATION OF SECURITY INTEREST (TRADEMARKS)

THIS TERMINATION OF SECURITY INTEREST (this "Termination"), dated as of May 10, 2022, is executed by MONROE CAPITAL MANAGEMENT ADVISORS, LLC, a Delaware limited liability company, as administrative agent for itself, the Lenders and certain Affiliates of the Lenders (the "Agent"), in favor of SYNERGY ENVIRONMENTAL CORPORATION, a Georgia corporation ("Grantor").

A. To secure the payment, performance, and observance of the Secured Obligations (as that term is defined in that certain Guaranty and Collateral Agreement dated as of April 29, 2016 and executed by Grantor and the other entities party thereto as Grantors in favor of Administrative Agent), Grantor granted to Administrative Agent a security interest, pursuant to that certain Trademark Security Agreement dated April 29, 2016 executed by Grantor in favor of Administrative Agent and recorded with the United States Patent and Trademark Office on May 2, 2016 at Reel/Frame: 5781/0130 (the "Trademark Security Agreement"), in the following collateral (the "Trademark Collateral"): the trademarks and corresponding registrations more particularly described on Schedule I annexed to this Termination and made part of this Termination for all purposes (the "Trademarks"), the goodwill of the business symbolized by the Trademarks, the customer lists and records related to the Trademarks, and any and all causes of action which may exist by reason of infringement of the Trademarks and all damages awarded therefrom, all proceeds of the foregoing, and all other Trademark Collateral (as defined in the Trademark Security Agreement).

B. Administrative Agent now wishes to terminate the security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Administrative Agent does hereby terminate the security interest in the Trademark Collateral.
