FOURTH: The merger is to become effective on July 31, 2018.

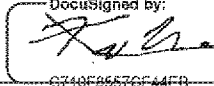
FIFTH: The Agreement of Merger is on file at 1 Renwick Street, New York, NY 10013, the place of business of the surviving corporation.
