## TRADEMARK COLLATERAL AGREEMENT

This Trademark Collateral Agreement is dated as of the 16<sup>th</sup> day of May, 2022.

### WHEREAS:

- A. ENTOURAGE BRANDS CORP., successor by name change to WeedMD RX Inc., a Canadian federal corporation ("*Debtor*") with its mailing address at 276 Queen Street West, Suite 200, Toronto ON M5V 2A1 and BANK OF MONTREAL, a Canadian chartered bank ("*BMO*"), with its mailing address at 100 King Street West, 18<sup>th</sup> Floor, Toronto, ON M5X 1A1, are party to a credit agreement dated as of March 29, 2019 (as amended, supplemented, restated or replaced from time to time, the "*Credit Agreement*") between Debtor as borrower, certain affiliates of Debtor as guarantors, BMO acting as administrative agent (and any successor(s) or assign(s) to BMO acting in such capacity (in that capacity, the "*Agent*"), and the lenders parties to the Credit Agreement from time to time.
- B. Debtor and its affiliates acting as guarantors, as required under the Credit Agreement, have entered into a General Security Agreement dated as of March 29, 2019 (as amended, supplemented, restated or replaced from time to time, the "*Security Agreement*") in favour of the Agent.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Debtor hereby pledges to, assigns, mortgages and grants to the Agent for the benefit of itself and the lenders under the Credit Agreement from time to time a continuing security interest in any and all trademarks now owned or acquired in the future, including without limitation:

- (a) each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and
- (b) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages;

to secure the payment and performance of all Secured Liabilities of Debtor and certain affiliates of Debtor as set out in the Security Agreement.


Notwithstanding anything herein to the contrary, this Trademark Collateral Agreement shall not operate as a sale, transfer, conveyance or other assignment to the Agent of any applications by Debtor for a trademark based on an intent to use the same if and so long as such application is pending without a Statement of Use having been filed and accepted (such pending applications which are based on intent to use

being hereinafter referred to collectively as “*Intent-To-Use Applications*”), but rather, if and so long as Debtor’s Intent-To-Use Application is pending without a Statement of Use having been filed and accepted, then this Trademark Collateral Agreement shall operate only to create a security interest for collateral purposes in favor of the Agent on such Intent-To-Use Application as collateral security for the Secured Obligations. When a Statement of Use is filed and accepted by the Trademark Office, then that application shall cease to be partly exempted from this Trademark Collateral Agreement.

Debtor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the assignment, mortgage, pledge and security interest in the trademarks, trademark registrations, and trademark applications made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

**IN WITNESS WHEREOF**, Debtor has caused this Trademark Collateral Agreement to be duly executed as of the date and year last above written.
