FIRST: The Board of Directors of the Corporation adopted resolutions proposing and declaring advisable that the Certificate of Incorporation of the Corporation, be amended, as follows:

RESOLVED: That the Board recommends and declares it advisable that the Certificate of Incorporation of the Corporation (the "**Certificate of Incorporation**"), be amended as following:

1. By deleting Article FIRST of the Certificate of Incorporation in its entirety and replacing it with the following: "The name of the corporation (the "**Corporation**") is Green Roads, Inc."
2. By deleting Article FOURTH of the Certificate of Incorporation in its entirety and replacing it with the following: "The total number of shares of capital stock that the Corporation shall have authority to issue is 500 shares of common stock, \$0.0001 par value per share."

RESOLVED: That the aforesaid proposed amendment be submitted to the stockholder of the Corporation for its consideration and approval.

RESOLVED: That following the stockholder' approval of the aforesaid proposed amendment as required by law, the officers of this Corporation be, and they hereby are, and each of them acting singly hereby is, authorized and directed (i) to prepare, execute and file with the Secretary of State of the State of Delaware a Certificate of Amendment to the Certificate of Incorporation (the "**Certificate of Amendment**") setting forth the aforesaid amendment to the Corporation's Certificate of Incorporation and (ii) to take any and all other actions necessary, desirable or convenient to give effect to such Certificate of Amendment or otherwise to carry out the purposes of the foregoing Resolutions.
