**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

May 17, 2022

WHEREAS, Rolands & Associates Corporation, a California corporation, (the "Company") is party to (i) that certain Security Agreement Supplement, dated as of May 7, 2021 (as heretofore amended, modified or supplemented, the "Security Agreement"), and (ii) that certain Trademark Security Agreement, dated as of May 7, 2021 (the "Trademark Security Agreement" and, together with the Security Agreement, the "Agreements"), by the Company in favor of JPMORGAN CHASE BANK, N.A., in its capacity as Administrative Agent (the "Agent"), pursuant to which the Company granted a security interest (the "Security Interest") in all of the Company's right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the trademark registrations and trademark applications set forth on the attached Schedule A, all to the extent set forth in the Agreements;


WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on (i) May 17, 2021, at Reel 7285, Frame 0095; and

WHEREAS, all of the obligations secured by the Security Interest have been fully paid and satisfied and the Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, without warranty or recourse of any kind, hereby releases its Security Interest held in the Trademark Collateral, including without limitation the trademark registrations and trademark applications set forth on Schedule A, and hereby (i) terminates all of its rights, powers, privileges and remedies under the Agreements with respect to the Trademark Collateral, (ii) re-conveys, re-transfers and sets over to the Company any right, title or interest that the Agent may have acquired in the Trademark Collateral, together with all the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Agreements related to the Trademark Collateral.
