## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") executed as of May 17, 2022, by WINTRUST BANK, N.A., a national banking association ("Lender"), in favor of FAIRWAY LAWNS, LLC, an Arkansas limited liability company ("Borrower").

WHEREAS, pursuant to that certain Amended and Restated Loan and Security Agreement and Guaranty dated as of November 19, 2021, by and among the Borrower, the Lender and the other parties thereto (as such may have been amended, supplemented or otherwise modified from time to time), and that certain Confirmatory Grant of Security Interest in Intellectual Property by Borrower for the benefit of Lender, dated as of December 23, 2019, and recorded in the United States Patent and Trademark Office on December 26, 2019, at Reel/Frame No. 6833/0009, the Borrower has granted to the Lender a security interest in the Borrowers' personal property constituting Collateral, as defined in the foregoing agreements, including without limitation the items of intellectual property listed in EXHIBIT A to this Release (hereinafter, collectively, the "IP Collateral"); and

WHEREAS, the Lender has agreed to terminate and release the aforementioned security interest in the IP Collateral.


NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, without representation or warranty of any kind, the Lender hereby releases, assigns, transfers, quitclaims, and conveys to the Borrowers all of the Lender's right, title and interest held in the IP Collateral, which includes without limitation the items of IP Collateral listed in EXHIBIT A to this Release, and hereby releases, discharges, cancels, extinguishes, and terminates the Lender's lien and security interest in the IP Collateral.

The Lender agrees to take all further actions, and provide to the Borrowers, all such cooperation and assistance (including the execution and delivery of any and all documents or other instruments), reasonably requested by the Borrowers, and at the Borrowers' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
