Preliminary Statement

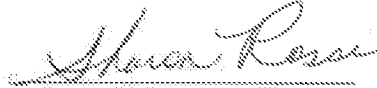
- A. The name of the company filing these Amended and Restated Articles of Organization (the "Articles") is FoodScience, LLC (the "Company").
- B. The Company was formed by filing Articles of Organization (the "Original Articles") with the Vermont Secretary of State on March 4, 2021, such Original Articles being filed in connection with the filing of a Statement of Conversion which converted the Company from a Vermont corporation to a Vermont limited liability company.
- C. The name of the Company in the Original Articles was "Foodscience, LLC." The member of the Company deems it in the Company's best interest to amend and restate the Original Articles in their entirety as follows, and amend the name to "FoodScience, LLC."

- 1. Name. The name of the company is FoodScience, LLC.
- 2. Purpose. The Company is a limited liability company in accordance with 11 V.S.A. Chapter 25. The purpose of the Company shall be to manufacture nutritional supplements, food, and products for human and pet consumption, and engage in any lawful business that may be engaged in by a limited liability company organized under the Vermont Limited Liability Company Act (the "Act"), as determined by the managing member from time to time.
- 3. Initial Office. The physical and mailing address of the initial designated office of the Company is 929 Harvest Lane, Williston, Vermont 05495.
- 4. Initial Registered Agent. The name and physical and mailing address of the initial registered agent of the Company for service of process is National Registered Agents, Inc., 17 G W Tatro Drive, Jeffersonville, VT 05464.
- 5. Term. The Company is an at-will limited liability company.
- 6. Member-Managed. The Company has one or more members at the time of the filing of the Articles. The Company is a member-managed limited liability company as defined in the Act.
