**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of May 17, 2022 is made by FEAC Agent, LLC, as administrative agent and collateral agent (in such capacity, including any successors thereto, the "Agent") for the Credit Parties.

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of November 12, 2021 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Grantors from time to time party thereto, the Lenders from time to time party thereto and Agent, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Grant of Security Interest in United States Trademarks, dated as of November 12, 2021 (the "Trademark Security Agreement"), a lien on and security interest (collectively, the "Security Interest") was granted by WITH YOU LLC (the "Trademark Grantor") to the Agent, as grantee, in certain collateral, including (i) all of Trademark Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications set forth on Schedule 1 attached hereto (the "Marks"), (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office November 15, 2021 at Reel/Frame 7494/0507.

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral, including those trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:


1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement or the Security Agreement, as applicable.
2. Release of Security Interest. The Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Recordation. The Agent authorizes the Trademark Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Trademark Grantor's expense.




