RELEASE OF SECURITY INTEREST

This Release of Security Interest (the "Release") is effective as of May 17, 2022, by PNC Bank, National Association, a Pennsylvania national banking association (hereinafter, "Secured Party").

WHEREAS, reference is made to that certain Trademark and Patent Security Agreement dated as of April 11, 2011 (hereinafter, "Security Agreement #1") and that certain Trademark and Patent Security Agreement (hereinafter, the "Security Agreement #2" and, together with Security Agreement #1, the "Agreements") dated as of December 31, 2014, by United Gilsonite Laboratories, a Pennsylvania corporation (hereinafter, the "Grantor"), in favor of Secured Party;

WHEREAS, pursuant to the Agreements, the Grantor granted to the Secured Party a security interest and continuing lien in certain collateral, including, without limitation, the trademarks and patents ("Collateral") as described in the Agreements; and

WHEREAS, the Security Agreement #1 was recorded with the United States Patent and Trademark Office on June 15, 2011 at Reel/Frame 4564/0789.

WHEREAS, the Security Agreement #2 was recorded with the United States Patent and Trademark Office on January 5, 2015 at Reel/Frame 5433/0885.

NOW, THEREFORE, for good and valuable consideration and intending to be legally bound hereby and in connection with the Agreements, Secured Party hereby irrevocably releases and remits, without any recourse, representation or warranty, any and all rights, title and interests in and to the Collateral, including, without limitation, the trademarks set forth on Exhibit A attached hereto for Security Agreement #1 and Exhibit B attached hereto for Security Agreement #2, and hereby authorizes the Grantor or Grantor's authorized representative to record this Release with the United States Patent and Trademark Office as evidence of such release.
