Termination of Security Interest

THIS TERMINATION OF SECURITY INTEREST (this "Termination"), dated as of May 16, 2022, is executed by FIFTH THIRD BANK, NATIONAL ASSOCIATION as agent (in such capacity, "Agent") for the lenders from time to time party to the Credit Agreement (as defined below), in favor of KUSTOM US, INC., an Ohio corporation (the "Grantor").

A. To secure the payment, performance, and observance of the Obligations (as that term is defined in that certain Credit Agreement, dated as of April 30, 2021, by and among, *inter alia*, the Agent and the Grantor (the "Credit Agreement")), the Grantor granted to the Agent a security interest, pursuant to that certain Trademark Security Agreement, dated as of April 30, 2021, executed by the Grantor in favor of the Agent and recorded with the United States Patent and Trademark Office (the "USPTO") on May 7, 2021, at Reel/Frame: 7285/0295 (the "Trademark Security Agreement"), in the Collateral described therein, including, but not limited to, the trademarks, trademark registrations, trademark applications, and trademark licenses set forth on Schedule 1 annexed to this Termination and made part of this Termination for all purposes (such Collateral, the "Trademark Collateral").

B. The Agent now wishes to terminate the security interest in the Trademark Collateral.

C. All capitalized terms used herein not otherwise defined herein have the meanings given to them in the Credit Agreement and/or the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:


1. terminates the Trademark Security Agreement;
2. terminates, cancels, discharges and releases any and all liens on, all of its rights in, to and under including its security interest in and to the Trademark Collateral arising under the Trademark Security Agreement, including, but not limited to, the trademarks, trademark registrations, trademark applications, and trademark licenses set forth on Schedule 1 annexed to this Termination; and Agent hereby reassigns any and all right, title and interest (if any) that Agent may have in, to or under the Trademark Collateral to Grantor; and
3. authorizes the recordation of this Termination with the USPTO at the Grantor's expense.

THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PROVISIONS (OTHER THAN SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW).
