**NOTICE OF TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This NOTICE OF TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), effective as of May 13, 2022, is made by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent for the lenders (referred to herein as the "Agent"), in favor of STRATUM RESERVOIR (US), LLC, a Delaware limited liability company (the "Grantor").

**WITNESSETH:**

WHEREAS, pursuant to (a) the Credit Agreement, dated as of April 30, 2019 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Credit Agreement"), among Stratum Reservoir Intermediate, LLC (the "Borrower"), Energy Reservoir Holdings, LLC, the Lenders, and the Agent, and (b) that certain Pledge and Security Agreement, dated as April 30, 2019, in favor of the Agent (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Pledge and Security Agreement"), by and among the Borrower, Stratum Reservoir Holdings, LLC, the Grantor, the other Credit Parties from time to time party thereto, and the Agent, the Grantor pledged and granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest (the "Security Interest") in all Intellectual Property Collateral, including Trademark Collateral (as that term is defined in the Pledge and Security Agreement);

WHEREAS, in furtherance of the Pledge and Security Agreement, the Grantor and the Agent entered into that certain Grant of Security Interest in Trademark Rights, dated as of April 30, 2019 (the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on May 20, 2019 at Reel/Frame No. 006649/0612;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein, terms used in this Termination and Release, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement, the Pledge and Security Agreement or the Trademark Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Agent, without recourse, representation or warranty of any kind, hereby terminates, releases, discharges, and cancels its Security Interest in and to the Trademark Collateral, including but not limited to the trademarks listed on Schedule A attached hereto, if any. The Agent, without recourse, representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement.

SECTION 3. Recording. The Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Termination and Release.

SECTION 4. Governing Law. This Termination and Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York.
