TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment"), effective as of October 23 2021 (the "Effective Date"), is entered into by and between Laird Connectivity Holdings LLC, an entity organized under the laws of the state of Delaware, having an address at 1 Perimeter Road, Manchester, New Hampshire 03013, U.S.A. ("Assignor") and

TE Connectivity Solutions GmbH, an entity organized under the laws of Switzerland, having an address at Mühlenstrasse 26, CH-8200 Schaffhausen, Switzerland ("Assignee").

RECITALS

WHEREAS, Assignor owns the trademarks set forth on Schedule 1 hereto ("Assigned Trademarks") and desires to assign, convey, transfer, deliver and vest all of its right, title and interests in and to the Assigned Trademarks, and associated goodwill, for all jurisdictions throughout the world, including all countries and political entities, to and in Assignee; and

WHEREAS, Assignee desires to accept from Assignor the Assigned Trademarks together with all associated goodwill.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby irrevocably assigns, conveys, transfers and delivers to Assignee, and Assignee hereby accepts, all of Assignor's entire, worldwide (for all jurisdictions throughout the world, including all countries and political entities) right, title and interest in and to the Assigned Trademarks, together with all associated goodwill, including, but not limited to, all rights to invoke and claim priority thereto for all jurisdictions, together with all income, royalties or payments due, accrued, or payable as of the Effective Date or thereafter, including, without limitation, any and all claims or causes of action for profits and damages by reason of past infringement of the Assigned Trademarks.

2. Assignor hereby consents that a copy of this Assignment shall be deemed a full and formal equivalent of any assignment, consent to file, or like document, which may be required in any country or region for recordation purposes for any of the foregoing rights conveyed herein. Following the date hereof, upon Assignee's reasonable request, and at Assignee's sole cost and expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned Trademarks to Assignee, or any assignee or successor thereto.

3. This Assignment shall be governed by and construed in accordance with the laws

of the State of Delaware, without regard to the conflicts of law principles of such state.


4. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

This Assignment may be executed in one or more counterparts and delivered via facsimile, pdf, or other electronic means, each of which shall be deemed an original as against the party that signed it and all of which shall together constitute one and the same agreement, and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other party, it being understood that all parties need not sign the same counterpart.

IN WITNESS WHEREOF, the parties hereto have caused this Assignment to be executed as of the Effective Date set forth above.


