## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("**Release**") is made and effective as of April 28, 2022, and granted by Wells Fargo Bank (the "**Lender**"), a National Association, in favor of Style Crest, Inc. ("SCF"), Style Crest Logistics, Inc. ("SCL"), Style Crest Real Estate, Inc. ("SCRE") and Style Crest Transport, Inc. ("STF", SCI, SCL, and SCRE are collectively known as the "**Borrowers**") and their successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Credit and Security Agreement dated as of March 19, 2014 (the "**Credit Agreement**") among the Borrowers, and the Lender, the Borrowers executed and delivered to the Lender that certain Trademark Security Agreement by and among the Borrowers and the Lender dated as of March 19, 2014 (the "**Trademark Security Agreement**").

WHEREAS, pursuant to the Trademark Security Agreement, each Borrower pledged and granted to the Lender a security interest in and to all of the right, title and interest of such Borrower in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5246, Frame 0907 on March 31, 2014; and

WHEREAS, the Grantors have requested that the Lender enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantors of any and all right, title and interest the Lender and the Secured Parties may have in the Trademark Collateral pursuant to the Trademark Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby states as follows:

1. Release of Security Interest. Lender, on behalf of itself, its successors, legal representatives and assigns, hereby terminates the Trademark Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Trademark Security Agreement in any and all right, title and interest of the Grantors (as defined in the Trademark Security Agreement), and reassigns to the Grantors any and all right, title and interest that it may have, in, to and under the following (collectively, the "**Trademark Collateral**"):

(a) All of Grantors' right, title and interest in and to: (i) trademarks, service marks, collective membership marks, registrations and applications for registration for each, and the respective goodwill associated with each, (ii) licenses, fees or royalties with respect to each, (iii) the right to sue for past present and future infringement, dilution and damages therefor, and (iv) licenses thereunder, all as presently existing or hereafter arising or acquired, including without limitation, the marks listed on Schedule I ("**Trademarks**").

2. Further Assurances. Lender agrees to take all further actions, and provide to the Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
