These Articles of Conversion are filed in accordance with Section 25.15.446 of the Revised Code of Washington (the "RCW"), and provide for the following:

1. By the filing of these Articles of Conversion, Vulcan Inc., a Washington corporation (the "**Converting Entity**"), is hereby converted into Vulcan LLC, a Washington limited liability company (the "**Surviving Entity**").
2. The name and form of the Converting Entity before conversion was Vulcan Inc., a Washington corporation.
3. The name and form of the Surviving Entity after the conversion shall be Vulcan LLC, a Washington limited liability company.
4. In accordance with RCW Chapter 25.15, the conversion shall be effective on October 31, 2021.
5. The conversion was duly approved by the sole member of the Board of Directors and the sole shareholder of the Converting Entity in accordance with Sections 23B.09.030 and 25.15 of the RCW, the governing statute of the Converting Entity.

These Articles of Conversion are hereby approved and executed by an authorized representative of the Converting Entity.

**CERTIFICATE OF FORMATION

THE UNDERSIGNED hereby executes the following Certificate of Formation for the purpose of forming a limited liability company under the Washington Limited Liability Company Act (Revised Code of Washington, Ch. 25.15).

**ARTICLE I  
NAME**

The name of this limited liability company is Vulcan LLC (the "LLC").

**ARTICLE II
