## TRADEMARK ASSIGNMENT

This Trademark Assignment is dated as of April 29, 2022 (the "Assignment") between, on the one hand, Lonris Limited Company, an entity registered in Hong Kong, having a registered address with the USPTO of 20<sup>th</sup> Floor, Central Tower, 28 Queen's Road, Hong Kong, Hong Kong (hereinafter "Assignor") and, Lonris LLC, a Delaware limited liability company, having an address of 8 The Green, Suite #12978, Dover DE 19901 (hereinafter "Assignee").

WHEREAS, Assignor owns: (1) U.S. Trademark Registration No. 5,959,423 ("the



'423 Registration") for the logo in international class 003 which was registered on January 14, 2020; (2) U.S. Trademark Registration No. 5,943,659 ("the



'659 Registration") for the logo in international class 003, which was registered on December 24, 2019; and (3) U.S. Trademark Registration No. 5,597,257 ("the '257 Registration") in international class 003, which was registered on October 30, 2018 for the standard character mark LONRIS. Collectively, the '423 Registration, the '659 Registration, and the '257 Registration are referred to herein as the '423, '659 and '257 Registrations. Assignor, has agreed to transfer, sell, and assign to Assignee and Assignee desires to accept the transfer and assignment of all of Assignor's rights, title, and interest in, to and under the '423, '659 and '257 Registrations.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby assigns to Assignee all rights, title, and interest in and to the '423, '659 and '257 Registrations, together with any goodwill associated therewith.
2. Rights and Privileges. Assignor hereby assigns all rights and privileges, including the right to sue for and receive all damages from past, present, and future infringement of the '423, '659 and '257 Registrations, will be held and enjoyed by Assignee and its successors, assigns, and other legal representatives.
3. Further Assurances. Assignor agrees to execute and deliver at a future date any additional documents that Assignee reasonably determines are required to perfect Assignee's ownership of, or title to, the '423, '659 and '257 Registrations.
4. Authorization. Assignor authorizes and requests any official throughout the United States whose duty it is to register and record ownership in trademark registrations and applications for registration of trademarks, to record Assignee as the assignee and owner of the '423, '659 and '257 Registrations.
5. Right to Convey. Assignor is the owner of all right, title, and interest in and to the '423, '659 and '257 Registrations. Assignor hereby covenants that it has full right to convey the entire interest herein assigned and that it has not executed, and will not execute, any agreement in conflict with this Trademark Assignment.
6. Governing Law. This Assignment shall be governed by, and construed in accordance with, the law (both substantive and procedural) of the Commonwealth of Virginia, exclusive of the application of conflict of laws principles, except that federal law, where applicable, shall be the governing law, to the extent required, with respect to issues involving trademarks.
