RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this “Release”) is dated as of May 23, 2022, by TORONTO DOMINION (TEXAS) LLC, in its capacity as collateral agent for the Secured Parties (together with any successors and permitted assigns thereto in such capacity, the “Collateral Agent”), in favor of Accion Labs US, Inc. (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement, dated as of December 24, 2020 among ACCION LABS MIDCO, LLC, a Delaware limited liability company (“Holdco Guarantor”), ACCION LABS HOLDINGS, INC., a Delaware corporation (the “Borrower”), the LENDERS party hereto from time to time, the Issuing Banks party hereto from time to time and TORONTO DOMINION (TEXAS) LLC, as Administrative Agent and Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) and the Trademark Security Agreement, dated as of December 24, 2020, among, *inter alios*, the Collateral Agent and the Grantor (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Intellectual Property Security Agreement”)

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 28, 2020 at Reel 7196, Frame 0143;

WHEREAS, pursuant to the terms and conditions of the Intellectual Property Security Agreement, the Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties a security interest in (the “Security Interest”) all of the Grantor’s right, title and interest in and to the Collateral, including registered Patents and Patent applications as set forth on Schedule I attached hereto (collectively, the “IP Collateral”); and

WHEREAS, the Collateral Agent desires to terminate and release the Security Interest in the IP Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of itself and the lenders under the Credit Agreement, hereby terminates, releases and forever discharges the Security Interest in the IP Collateral, and retransfers and reassigns to the Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Collateral Agent, all right, title or interest of the Collateral Agent in, to or under the IP Collateral of the Grantor.
