AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY INTEREST

This Affidavit to Affirm the Release of Security Interest is effective as _____ pursuant to the fulfillment of the loan obligations.

I, Phil Rogers, do hereby declare as follows.

1. I am the Chief Exertive Officer of Square Enix Limited, an English corporation.
2. Eidos Interactive Limited (“**Company**”) changed its name to Square Enix Limited.
3. Pursuant to that certain Deed of Charge of Intellectual Property, dated as of January 31, 2008 (the “**Security Agreement**”), Company granted Lloyds TSB Bank PLC (the “**Lender**”) a security interest (the “**Security Interest**”) in the trademark registrations set forth on Schedule A attached hereto (the “**Trademarks**”).
4. The Security Agreement was recorded at the United States Patent and Trademark Office (the “**USPTO**”) on April 15, 2008 at Reel/Frame 3759/0745 with respect to the Trademarks.
5. To the best of my knowledge: (a) the obligations secured under the Security Agreement were satisfied; (b) Company repaid in full the loan made by Lender to Company under the Security Agreement; and (c) Lender released the Security Interest in the Trademarks.
6. Due to unknown reasons, a release of the Security Interest was not previously filed with the USPTO.
7. The undersigned, being hereby advised that willful false statement and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, declares that the facts set forth in this affidavit are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
8. The undersigned has personal knowledge of these facts and attests to their truth.
