IP SUPPLEMENT

This IP SUPPLEMENT, dated as of May 26, 2022 is delivered pursuant to and supplements (i) the Security Agreement, dated as of September 4, 2020 (said Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time being the “Security Agreement”), by and among Tropical Smoothie Café Holdings, LLC, a Delaware limited liability company, the other Debtors party thereto from time to time, and Golub Capital LLC, as Administrative Agent, and (ii) the Trademark Security Agreement dated as of September 4, 2020 (the “IP Security Agreement”) executed by Debtor. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the IP Security Agreement.

Debtor grants to the Administrative Agent a security interest in all of Debtor’s right, title and interest in and to the trademarks set forth on Schedule A annexed hereto. All such trademarks shall be deemed to be part of the Collateral and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the IP Security Agreement.
