TRADEMARK ASSIGNMENT

This ASSIGNMENT (the "Assignment") is made effective as of the 18 day of May, 2022 (the "Effectivity Date"), by and between TRIPHARMA, LLC, a California limited liability company ("*Assignor*"), and THINGS OF THAT NATURE, INC., a California corporation, having a place of business at 120 Newport Center Drive, Newport Beach, California 92660 ("*Assignee*").

WHEREAS, Assignor is the record owner of the U.S. trademark set forth on Schedule A attached hereto and made a part hereof, including all common law rights thereto (the "*Trademark*"), and the goodwill of the business symbolized thereby (together with the Trademark, the "*Assigned Property*").

WHEREAS, Assignor agrees to assign their entire right, title and interest in and to the Assigned Property to Assignee; and

WHEREAS, Assignee agrees to acquire Assignor's entire right, title and interest in and to the Assigned Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignor is the sole and exclusive owner of the entire and unencumbered right, title and interest in and to the Assigned Property, free and clear of any liens, charges and encumbrances, including, without limitation, licenses and covenants by Assignor not to sue third persons, and Assignor hereby assigns to Assignee, its successors and assigns, their entire right, title and interest in and to the Trademark, and all rights and privileges pertaining to said Trademark in conformance with 15 U.S.C. §1060; 37 C.F.R. §3.16, together with the goodwill of the business symbolized by the Trademark, including all income, royalties, damages, and payments now or hereafter due or receivable in respect of the Trademark, and all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringements, misappropriations, or dilutions of the rights assigned to Assignee hereunder, and all rights corresponding thereto throughout the world.

2. The Trademark is subsisting and has not been adjudged invalid or unenforceable, in whole or in part.

3. And for the above-named consideration, Assignor does hereby agree to, at the request of the Assignee, execute any and all papers and documents and do all other and further lawful acts that the Assignee may deem necessary or desirable to perfect and vest in the Assignee the entire right, title and interest in the intellectual property being assigned.
