**RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT
AND REASSIGNMENT OF PATENT AND TRADEMARKS**

May 9, 2022

Reference is hereby made to that certain Patent and Trademark Security Agreement, dated as of June 9, 2017 (the "Security Agreement"), executed by AERGO SOLUTIONS LLC, a Tennessee limited liability company (the "Company") whose address is 33 Wood Avenue South, Suite 840, Iselin, NJ 08830, in favor of DEERPATH FUND SERVICES, LLC, a Delaware limited liability company, as administrative agent and collateral agent (the "Agent") whose address is 405 Lexington Avenue, 53rd Floor, New York, New York 10174, which was recorded with the Patent Branch of the United States Patent and Trademark Office on June 14, 2017 at Reel 042704, Frame 062, and with the Trademark Branch of the United States Patent and Trademark Office on April 8, 2019 at Reel 6612, Frame 0219, pursuant to which the Company mortgaged, pledged and granted to the Agent, for the ratable benefit of the Lenders (as defined in the Security Agreement), a continuing security interest in, and lien on, all of the Company's IP Collateral (as defined in the Security Agreement), including the patent and trademarks specifically listed on Schedule 1 attached hereto and the goodwill associated therewith;

WHEREAS, the Obligations (as defined in the Security Agreement) have been paid in full and Agent wishes to terminate the Security Agreement, release said security interest in, and lien on, all of the Company's IP Collateral, and retransfer and reassign to the Company, without representation or warranty, all of Agent's right, title and interest in and to the IP Collateral and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby (i) terminates the Security Agreement, (ii) releases said security interest in and to the IP Collateral, (iii) cancels, releases, terminates and discharges any and all of its right, title and interest in the IP Collateral, and (iv) transfers (or retransfers) and assigns (or reassigns) to the Company, without representation or warranty, all of Agent's right, title and interest in and to the IP Collateral together with the goodwill associated therewith.
