RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of May 16, 2022 (the “Effective Date”), is made by UMB Bank, National Association, as notes collateral agent (in such capacity, the “Collateral Agent”) for the Secured Parties (as defined in the Security Agreement referred to below), in favor of Del Monte Foods, Inc. (“Grantor”).

WHEREAS, the Grantor has entered into the Indenture, dated as of May 15, 2020 (as amended, supplemented or otherwise modified from time to time, the “Indenture”), among the Grantor, Del Monte Food Holdings Limited (“Holdings”), certain of Holdings’ Subsidiaries signatories thereto (Holdings and each such Subsidiary, collectively, the “Guarantors”) and UMB Bank, National Association, in its capacity as Trustee on behalf of the Holders of the Notes and Collateral Agent;

WHEREAS, in connection with the Indenture, the Grantor and the Guarantors have entered into the Security Agreement, dated as of May 15, 2020 in favor of the Collateral Agent for the benefit of the Secured Parties (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantor and the Collateral Agent have entered into a certain Trademark Security Agreement, dated as of May 15, 2020 and recorded on May 26, 2020 with the U.S. Patent and Trademark Office (“USPTO”) at Reel/Frame No. 6946/0614 (the “Trademark Security Agreement”), in which the Grantor granted to the Collateral Agent a security interest in and to the trademarks listed on Schedule A thereto (the “Trademarks”); and

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in and to all of its right, title and interest in, to and under all Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent hereby states as follows:

SECTION 1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Indenture, the Security Agreement and the Trademark Security Agreement (collectively, the “Agreements”), as applicable.

SECTION 2. Release. The Collateral Agent hereby releases, discharges and terminates, without recourse, representation or warranty, all of its security interest, liens and encumbrances in, to and under the Trademarks, including the trademarks set forth in Schedule 1 attached hereto and incorporated herein by reference, and hereby discharges, relinquishes, transfers and assigns unto Grantor any right, title and interest it has in, to and under the Trademarks under the Agreements. The Collateral Agent authorizes and requests that this Release be recorded at the USPTO.

SECTION 3. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge, deliver and procure any further documents and to do such other acts as may be reasonably necessary, in each case, at Grantor's cost and expense, to effect the release of the security interest discussed herein.


