RECEIVER/ASSIGNOR represents that, as of the Effective Date, RECEIVER/ASSIGNOR was the owner of all right, title, and interest in and to all of the assets identified in EXHIBITS 1, 2 and 3, and that RECEIVER/ASSIGNOR has not assigned, transferred, licensed or encumbered RECEIVER'S/ASSIGNOR'S rights therein, and that RECEIVER/ASSIGNOR will not hereafter assign or attempt to assign any rights therein, or take any other action inconsistent with this Assignment.

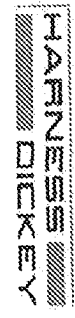

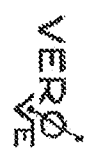
