NOTICE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

Reference is made to (i) that certain Syndicated Facility Agreement, dated as of October 20, 2014 by and among Aristocrat International PTY LTD ACN 000 148 158, a corporation registered in New South Wales (“AIP”), Aristocrat Technologies Australia PTY Limited ACN 001 660 715, a corporation registered in New South Wales (“ATA”) and Aristocrat Technologies, Inc., a Nevada corporation (“ATI”), Video Gaming Technologies, Inc., a Tennessee corporation (“VGT”), Aristocrat Leisure Limited ACN 002 818 368, a corporation registered in New South Wales (“Holdings”), UBS AG, Stamford Branch, as Administrative Agent for the Term Lenders (in such capacity, the “Agent”) and as Security Trustee for the Secured Parties (in such capacity, the “Security Trustee”) and certain other parties thereto (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the Effective Date, the “Original Credit Agreement”), (ii) that certain Security Agreement, dated as of October 20, 2014 by each of the signatories thereto in favor of the Security Trustee (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the Effective Date, the “Security Agreement”), (iii) the Trademark Security Agreement, dated as of October 20, 2014 by ATI and VGT in favor of the Security Trustee (the “2014 Trademark Security Agreement”) and (iv) the Trademark Security Agreement, dated as of May 23, 2016 by ATI and VGT in favor of the Security Trustee (the “2016 Trademark Security Agreement” and together with the 2014 Trademark Security Agreement, the “Trademark Security Agreements” and each, a “Trademark Security Agreement”).

WHEREAS, pursuant to the Security Agreement and each of the Trademark Security Agreements, ATI and VGT granted to the Security Trustee a security interest in the Trademark Collateral (as defined in the applicable Trademark Security Agreement), including (as applicable) those trademarks, and registrations and applications thereof, listed in Schedule A;

WHEREAS, the 2014 Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on December 22, 2014 at Reel/Frame 5424/0395 (ATI) and 5424/0434 (VGT) and the 2016 Trademark Security Agreement was recorded with the USPTO on June 10, 2016 at Reel/Frame 5811/0643;

WHEREAS, UBS AG, Stamford Branch, as resigning Agent, UBS AG, Stamford Branch as resigning Security Trustee (in such capacity, the “Resigning Security Trustee”), Bank of America, N.A., as successor Agent and as successor Security Trustee (in such capacity, the “Successor Security Trustee”), AIP, ATA, ATI, VGT, Holdings, and certain other parties have entered into that certain Agency Resignation, Appointment and Assumption Agreement, dated as of May 24, 2022 (the “Agency Transfer Agreement”), whereby, among other things, the Resigning Security Trustee resigned as Security Trustee and is succeeded to and replaced by the Successor Security Trustee as successor Security Trustee; and

WHEREAS, the Resigning Security Trustee and the Successor Security Trustee have agreed to execute this Notice of Assignment of Security Interest in Trademarks (this “Notice”) to evidence the assignment of the Resigning Security Trustee’s security interest in the Trademark Collateral for recordation with the USPTO.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Original Credit Agreement.

2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Agency Transfer Agreement, as of the Effective Date, the Resigning Security Trustee (a) resigned as and ceased to be Security Trustee under the Security Agreement and the Trademark Security Agreements and, other than expressly set forth in the Agency Transfer Agreement, the Resigning Security Trustee's rights, powers and duties as Security Trustee thereunder have been terminated, (b) is succeeded and replaced by the Successor Security Trustee as Security Trustee, and (c) assigned to the Successor Security Trustee, without recourse, representation or warranty, (i) each of the Liens and security interests in the Trademark Collateral granted to the Security Trustee under the Security Agreement and the Trademark Security Agreements and (ii) all right, title, interest and duties of the Security Trustee under the Trademark Security Agreements, other than as expressly set forth in the Agency Transfer Agreement.


3. Continuity of Security Interest. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the Trademark Collateral originally granted to the Resigning Security Trustee under the Trademark Security Agreements.

4. Reference to Security Trustee. From and after the Effective Date, each of the undersigned agrees each reference in each Trademark Security Agreement to "Security Trustee" shall mean and be a reference to Bank of America, N.A., in its capacity as Successor Security Trustee.

5. Counterparts. This Notice may be executed in any number of counterparts, each of which shall constitute an original, but such counterparts shall together constitute but one and the same instrument.




