**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of May 25, 2022 (“Release”), is made by **PRIDES CROSSING CAPITAL, L.P.**, a Delaware limited partnership in its capacity as administrative and collateral agent in respect of the lenders (collectively, the “Lenders”) under the Notes and the Note Agreement (the “Agent”), in favor of **TRIALWORKS ACQUISITION LLC**, a Delaware limited liability company, with its principal place of business located at 53 Hill Street, Suite 25, Southampton, NY 11968 (“TrialWorks Acquisition”), and **TRIALWORKS LLC**, a Delaware limited liability company, with its principal place of business located at 1550 Madruga Avenue, Suite 508, Coral Gables, FL 33146 (“TrialWorks”, and together with TrialWorks Acquisition, jointly and severally, each a “Grantor” and collectively, the “Grantors”).

**WHEREAS**, pursuant to that certain (i) Note Purchase Agreement dated as of July 21, 2017 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Note Agreement”) by and between Grantors and Agent, and (ii) Amended and Restated Intellectual Property Security Agreement dated as of July 21, 2017 by and between Grantors and Agent (the “IP Agreement”, together with the Note Agreement, the “Loan Documents”), Grantors granted and conveyed to Agent a security interest in the entire right, title and interest of Grantors in and to all of Grantors’ Intellectual Property;

**WHEREAS**, the IP Agreement was recorded with the Trademark Division of the US Patent and Trademark Office (“USPTO”) on July 28, 2017 at Reel No. 6117, Frame No. 0217, for the trademarks listed on Schedule A attached hereto.

**WHEREAS**, the IP Agreement was recorded with the US Copyright Office (“USCO”) on August 1, 2017 as Document No. V9949D946, for the copyrights listed on Schedule B attached hereto.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender agrees as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Note Agreement, as applicable.

**SECTION 2. Termination and Release.** Lender, without representation, warranty, or recourse, hereby:

(a) terminates the IP Agreement and terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and liens on and security interests in and to the entire right, title, and interest of Grantor in and to all of Grantor’s Intellectual Property listed on Schedules A and B attached hereto, granted pursuant to the Loan Documents;

(b) re-assigns, grants and re-conveys to the Grantor any and all of the right, title, and interest of Grantor that may have been acquired in and to all of Grantor’s Intellectual Property listed on Schedules A and B; and




(c) authorizes the recordation of this Release with the USPTO and USCO, at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Delaware, without regard to its conflict of laws principles.
