**TERMINATION AND RELEASE OF SECURITY INTEREST**

This TERMINATION AND RELEASE OF SECURITY INTEREST, dated as of April 22, 2022, by and between **FIFTH THIRD BANK**, an Ohio banking corporation located at 38 Fountain Square, Cincinnati, Ohio 45263, in favor of Cincinnati Beverage Company, a Delaware Corporation with an address at 850 New Burton Road, Suite 201, Kent, Delaware 19904, current owner of all right, title, and interest in the trademark assets identified in Schedule A hereto.

WHEREAS, InCommand entered into a Trademark Security Agreement with Lender dated as of July 25, 2019, pursuant to which InCommand granted to Lender a security interests in and to the Trademark Collateral owned by InCommand;

WHEREAS, Lender filed with the United States Patent and Trademark Office (the "USPTO") a notice of security interest in Trademarks, which was recorded on July 29, 2019 at Reel 006705, Frame 0967;

WHEREAS, InCommand and Borrower entered into an Asset Purchase and Contribution Agreement dated March 16, 2020, which included an Intellectual Property Assignment Agreement assigning the Trademarks to Borrower, which assignment was filed with the USPTO on March 18, 2020 and recorded at Reel 06904, Frame 0595;

WHEREAS, Borrower entered into a Trademark Security Agreement with Lender dated as of March 16, 2020, pursuant to which Borrower granted to Lender a security interest in and to the Trademarks;

WHEREAS, Lender filed with the USPTO a notice of security interest in the Trademarks, which was recorded on March 20, 2020 at Reel 006897, Frame 0227; and

WHEREAS, Borrower has paid all outstanding amounts currently owing to Lender referenced in the Security Agreements and the Loan Documents executed therewith, and has requested that the Lender release its security interests in the Trademarks.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender agrees as follows:

1. Release of Security Interests. Effective as of the date hereof, Lender hereby irrevocably and forever terminates, releases, and discharges any and all security interests in the Trademarks granted by Borrower or InCommand.
2. Recordation of Release. The Lender authorizes the recordation of this Release with the USPTO at Borrower's expense.
3. Further Actions. Lender further agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Borrower may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be

prepared by counsel to Borrower and the cost and expense of such documents and actions shall be borne solely by Borrower.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreements.
