## **TERMINATION AND RELEASE OF SECURITY INTEREST**

This TERMINATION AND RELEASE OF SECURITY INTEREST (this “Release”) is entered into as of May 25, 2022, by VENTURE LENDING & LEASING IX, INC., a Maryland corporation (“Venture”), in favor of PEERWELL, INC., a Delaware corporation (the “Grantor”).

WHEREAS, Grantor is the record owner of the trademark registrations listed on **Schedule A** hereto (the “Trademarks”) and the patents and patent applications listed on **Schedule B** hereto (collectively, the “Patents”);

WHEREAS, pursuant to a certain Loan and Security Agreement dated August 13, 2020 by and among Grantor and Venture (the “Loan Agreement”), Venture made certain extensions of credit to Grantor upon the terms and conditions set forth therein. Capitalized terms used herein and not otherwise defined shall have the definitions set forth in the Loan Agreement.

WHEREAS, Grantor entered into that certain Intellectual Property Security Agreement dated August 13, 2020 (the “Security Agreement”), pursuant to which Grantor granted a security interest to Venture in the Trademarks and Patents, a true and correct copy of which was recorded by the United States Patent and Trademark Office against the Trademarks on August 14, 2020 at Reel 7025/Frame 0030 and against the Patents on August 14, 2020 at Reel 053505/Frame 0854:

WHEREAS, Venture now desires to release its security interest in the Trademarks and Patents and terminate the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is acknowledged:

1. Venture hereby releases, without recourse or representation or warranty, express or implied, any and all liens, security interests, right, title, and interest of Venture pursuant to the Security Agreement in and to the Trademarks, Patents and all other Collateral (as defined in the Security Agreement), and all of the goodwill of the business connected with the use of, and symbolized by, such Trademarks and Collateral;
2. Venture hereby terminates the Security Agreement; and
3. Venture authorizes and requests the Commissioner of United States Patent and Trademark Office to note and record the existence of the release hereby given.
