TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 31, 2022 (“Release”), is made by TCW Asset Management Company LLC, as agent (“Agent”), in favor of Winsight, LLC, a Delaware limited liability company (“Winsight”), and Technomic, Inc., a Delaware corporation (together with Winsight, each an “Assignor” and collectively, the “Assignors”).

WHEREAS, Agent, the Assignors, and certain other borrowers have entered into that certain Pledge and Security Agreement, dated as of November 15, 2018 (as from time to time amended, restated, supplemented or otherwise modified, the “Security Agreement”);

WHEREAS, pursuant to (i) that certain Assignment for Security - Trademarks, dated as of November 15, 2018, by the Assignors (the “2018 Security Agreement”), (ii) that certain Assignment for Security - Trademarks, dated as of January 7, 2019, by Winsight (the “2019 Security Agreement”), (iii) that certain Assignment for Security - Trademarks, dated as of September 3, 2020, by the Assignors (the “2020 Security Agreement”), (iv) that certain Assignment for Security Trademarks, dated as of April 30, 2021, by Winsight (the “2021 April Security Agreement”) and (v) that certain Assignment for Security Trademarks, dated as of May 25, 2021, by Winsight (the “2021 May Security Agreement”, and together with the 2018 Security Agreement, the 2019 Security Agreement, 2020 Security Agreement and the 2021 April Security Agreement, the “Trademark Security Agreements”), each Assignor granted to Agent, to secure its obligations under the Security Agreement, a security interest in all right, title and interest of such Assignor in and to certain intellectual property;

WHEREAS, the 2018 Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) at Reel 6483 Frame 0107 on November 16, 2018;

WHEREAS, the 2019 Security Agreement was recorded at the USPTO at Reel 6518 Frame 0753 on January 7, 2019;

WHEREAS, the 2020 Security Agreement was recorded at the USPTO at Reel 7049 Frame 0656 on September 3, 2020;

WHEREAS, the 2021 April Security Agreement was recorded at the USPTO at Reel 7277 Frame 0025 on April 30, 2021;

WHEREAS, the 2021 May Security Agreement was recorded at the USPTO at Reel 7306 Frame 0114 on May 25, 2021; and

WHEREAS, each Assignor has satisfied the terms of the Trademark Security Agreements and requests a specific release of the security interest granted and recorded against its intellectual property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreements, as applicable.

SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby:

(a) terminates the Trademark Security Agreements and terminates, cancels, discharges, and releases all of its security interests in and to all right, title and interest of each Assignor (and any of the borrowers or other obligors under the Security Agreement) in and to all intellectual property (including, but not limited to, all Collateral under each Trademark Security Agreement), whether granted pursuant to the Trademark Security Agreements or otherwise (and including, but not limited to, the Trademarks listed on Schedule A attached hereto);

(b) assigns and transfers to each Assignor all of its right, title and interest in and to all intellectual property, whether granted pursuant to the Trademark Security Agreements or otherwise (including, but not limited to the Trademarks listed on Schedule A attached hereto), together with the goodwill of the business symbolized thereby; and


(c) authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at each Assignor's expense.

The Agent agrees to take all further actions, and provide to each Assignor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Assignor, at such Assignor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.


