**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 31, 2022 (“Release”), is made by PNC Bank, National Association, as Agent (“Agent”) in favor of Interra International, Inc., a Georgia corporation (“Grantor”).

**WHEREAS**, pursuant to that certain Revolving Credit and Security Agreement dated as of June 9, 2014 (as amended, modified, extended or restated from time to time, the “Security Agreement”) by and among the Grantor, Agent, and others party thereto, Grantor assigned, pledged and granted to Agent for its benefit and for the ratable benefit of each Lender (collectively, the “Secured Parties”) a continuing security interest in and to and Lien on trademarks, trademark applications, and service marks, and associated goodwill, including, but not limited to, the foregoing listed on Schedule A attached hereto (collectively, “Trademark Collateral”);

**WHEREAS**, pursuant to the Security Agreement, Grantor executed and delivered to Agent the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on June 23, 2014 at Reel 5307 Frame 0549 (“Notice”).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in and to and Lien on the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Georgia.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
