**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of June 1, 2022, is made by ROYAL BANK OF CANADA, in its capacity as Administrative Agent for the Lenders and Secured Parties (the “**Administrative Agent**”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Amended and Restated Credit Agreement, dated as of May 15, 2018, among Deliver Buyer, Inc., as Borrower, Deliver Holdings II, LLC, as Holdings, the Subsidiaries of the Borrower from time to time party thereto, each Lender from time to time party thereto and Royal Bank of Canada, as Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the “**Credit Agreement**”)

WHEREAS, in connection with the Credit Agreement and together with all general security agreements, trademark security agreements and patent security agreements entered into in connection therewith, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the “**Security Agreements**”), the Borrower and certain of the other Loan Parties (together with the Borrower, the “**Grantors**”) granted security interests in the intellectual property owned by Grantors, including those listed on Annex I attached hereto (the “**Intellectual Property Collateral**”); and

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office (the “**USPTO**”) on the dates and on the reel and frame numbers set forth on Annex I hereto.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby cancels and terminates the Security Agreements described on Annex I attached hereto and releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the Intellectual Property Collateral to the Grantors.


