## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** dated as of June 1, 2022 (this "Release") is made by Comerica Bank, as Administrative Agent (the "Secured Party"), under the Trademark Security Agreement dated as of October 6, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and ABD EL & Jake Holdings, LLC (the "Debtor") and if recorded in the records of the United States Patent and Trademark Office.

**WHEREAS**, pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest ("Security Interest") in and to the entire right, title, and interest of Debtor in and to Debtor's trademark collateral as defined in the Security Agreement, including but not limited to the trademarks listed on attached Exhibit A (the "Released Trademarks").

**WHEREAS**, the Secured Party now wishes to release and terminate the Security Interest in the Released Trademarks.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party agrees as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement, as applicable.

**SECTION 2. Termination and Release.** Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the Lien (as defined in the Security Agreement) on and security interest in and to the entire right, title, and interest of Debtor in and to all of the Released Trademarks;

(b) and authorizes the recordation of this Release with the USPTO.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict of laws principles.
