**RELEASE OF SECURITY INTERESTS IN
TRADEMARKS**

This **RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of May 31, 2022, by HSBC Bank USA, National Association, (“Lender” and together with Affiliates of the Lender, the “Secured Parties”), in favor of Combat Medical Systems, LLC, Water-Jel Technologies, Inc. (collectively, the “Original Grantors”), and H&H Medical Corporation (“H&H”, and together with the Original Grantors, each, individually, a “Grantor”, and, collectively, the “Grantors”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreements (as defined below).

WHEREAS, (a) Lender and the Original Grantors are party to that certain Trademark Security Agreement, dated as of September 9, 2020 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the “Original Trademark Security Agreement”); (b) the Lender and H&H are party to that certain Trademark Security Agreement, dated as of May 14, 2021 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the “H&H Trademark Security Agreement”, and together with the Original Trademark Security Agreement, the “Trademark Security Agreements”);

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreements, the Grantors granted to the Lender, for its benefit and for the ratable benefit of each of the Secured Parties, a security interest in all of the Grantors’ right, title, and interest in and to the following, wherever located and whether now or hereafter existing or acquired (collectively, the “Trademark Collateral”):

(i) (a) all trade names, trademarks and service marks, logos, trademark and service mark registrations, and applications for trademark and service mark registrations, including all renewals of trademark and service mark registrations, all rights to recover for all past, present and future infringements thereof and all rights to sue therefor, and all rights corresponding thereto throughout the world, (all of the foregoing in this clause (a) being collectively called a “Trademark”), including, without limitation, each registered and applied for Trademark and all goodwill associated with or symbolized by each Trademark listed on listed on Schedule A hereto, together, in each case, with the product lines and goodwill of the business connected with the use of, and symbolized by, each such trade name, trademark and service mark; and

(ii) all Proceeds of any of the foregoing, all Accessions to and substitutions and replacements for any of the foregoing, and, to the extent related to any of the foregoing, all books, correspondence, credit files, records, invoices and other papers (including all tapes, cards, computer runs and other papers and documents in the possession or under the control of the Grantors or any computer bureau or service company from time to time acting for any Grantor.

WHEREAS, (a) the Original Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 11, 2020 at Reel/Frame 7049/0332; and (b) the H&H Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 18, 2021 at Reel/Frame 7296/0848; and

WHEREAS, the Lender has agreed to terminate and release the security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The Lender hereby terminates and releases in its entirety its security interest and lien in all of the Grantors' right, title, and interest in, to and under the Trademark Collateral, and reassigns to each Grantor any and all such right, title and interest in such Trademark Collateral, free and clear of all such security interest and lien.

2. To the extent the Lender retains any such interest, the Lender hereby assigns, transfers and conveys to the Grantors all of the Lender's right, title and interest, now owned or hereinafter acquired, that it may have, whether by assignment or otherwise, in and to any mortgage and continuing security interest in the Trademark Collateral, including, without limitation, the entire right, title and interest in and to the Trademark Collateral, all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto and the goodwill of the business to which the Trademark Collateral relates. Such assignment, transfer and conveyance by the Lender is made without any representation or warranty (express or implied) by the Lender, except that the Lender has not transferred or conveyed any interest therein.

3. This Release may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. Delivery by telecopier, .pdf or other electronic imaging means of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.

4. The Lender authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.

5. THIS RELEASE AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL EACH BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
