PREAMBLE

By a Trademark Assignment Deed dated September 23rd, 2021 [hereinafter THE AGREEMENT], THE ASSIGNOR transferred to THE ASSIGNEE the full and entire ownership of the trademark applications and registrations relating to the name FRANCOPIA, as listed in the schedule hereto [hereinafter THE TRADEMARKS].

THE PARTIES hereto wish to hereby confirm the assignment of THE TRADEMARK for the purpose of its recordal on the corresponding Trademark Register.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. THE ASSIGNOR hereby confirms the assignment to THE ASSIGNEE, with effect from September 23rd, 2021, of the full and entire ownership of THE TRADEMARK, with all rights and privileges, including the right to prosecute any acts of infringement or imitation of THE TRADEMARK and including the goodwill associated with THE TRADEMARK.
2. The present confirmatory deed confirms and neither replaces nor amends THE AGREEMENT.

Full power is given to the bearer of an original thereof, or a copy certified to be a true copy by Notary Public, or a simple copy thereof, in order to perform all necessary steps to record the referenced trademark assignment from Sanofi to Francopia on the relevant Trademark Registers.




