AMENDED AND RESTATED  
GRANT OF SECURITY INTEREST  
IN TRADEMARKS

April 11, 2022

WHEREAS, SMAC HEALTHCARE, LLC, a Delaware limited liability company ("SMAC") and CONANT CAPITAL, LLC, a Delaware limited liability company ("Conant" and together with SMAC, "Grantors" and each, a "Grantor") are the owners of the trademark applications and registrations listed on Schedule A attached hereto (all such trademarks, registrations and applications, collectively, the "Trademarks").

WHEREAS, each Grantor entered into a Security Agreement (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreements"), dated January 19, 2021, in which each Grantor granted to Salem Investment Partners IV, Limited Partnership, a North Carolina limited partnership with offices at 7900 Triad Center Drive, Suite 333, Greensboro, North Carolina 27409 ("Lender"), a security interest in all of such Grantor's right, title and interest in general intangibles, including without limitation, the Trademarks and agreed to execute a Grant of Security Interest in Trademarks.

WHEREAS, SMAC entered into a Grant of Security Interest in Trademarks (the "Original Grant"), dated December 30, 2021 with Lender, in which SMAC granted Lender a security interest in all of SMAC's right, title and interest in general intangibles, including without limitation, the Trademarks.

WHEREAS, Grantors and Lender desire to amend and restate the Original Grant in its entirety with this Amended and Restated Grant of Security Interest in Trademarks (the "A&R Grant").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Obligations (as defined in the Security Agreements), each Grantor does hereby grant to Lender a security interest in all of its right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks. This A&R Grant has been given in conjunction with the security interests granted to Lender under the Security Agreements, and the provisions of this A&R Grant are without prejudice to and in addition to the provisions of the Security Agreements, which are incorporated herein by this reference.

The security interest granted to Lender in this instrument shall exist continually until all Obligations (other than contingent obligations for which no claim has been made) have been paid in full. Upon such payment, Lender shall, at Grantors' request and expense, send such termination statements to Grantors or file them with any applicable filing office.
