TO: Troll Company A/S (the “**Purchaser**”)

AND TO: DHX USA Inc., (the “**Seller**”)

Dear Sirs:

Re: Intellectual Property Assignment

Reference is made to that certain Amended and Restated Credit Agreement, dated as of March 26, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), among, inter alios, WildBrain Ltd., a corporation incorporated under the federal laws of Canada (the “**Borrower**”), the lending institutions from time to time party thereto and Royal Bank of Canada, as administrative agent (“**Administrative Agent**”). All capitalized terms used herein and not otherwise defined shall have the same meaning set forth in the Credit Agreement.

The Administrative Agent is the secured party in respect of a certain Intellectual Property constituting Collateral under the Loan Documents, previously granted by the Seller, a wholly-owned subsidiary of the Borrower and a Grantor under the Security Agreement, to secure the Obligations of the Loan Parties under the Loan Documents, set forth in the attached in Schedule “A” hereto (the “**Released IP**”).

We understand that the Seller and the Purchaser are parties to a certain intellectual property purchase agreement, dated as of December 24th, 2021 (the “**IP Sale Agreement**”), pursuant to which the Seller is selling, and the Purchaser is purchasing the Released IP described in Schedule A of the IP Sale Agreement (the “**Disposition**”).

In connection with the Disposition, the Borrower, on behalf of the Seller, is requesting that the Administrative Agent, release its security interest in the Released IP in accordance with the provisions of the Loan Documents.


