**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (this “Release Agreement”), dated as of June 1, 2022, is made by **JPMORGAN CHASE BANK, N.A.**, in its capacity as administrative agent (the “Administrative Agent”) in favor of **STANDARD MOTOR PRODUCTS, INC.**, a New York corporation (the “Grantor”).

WHEREAS, the Grantor and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of January 15, 2019 (the “Trademark Security Agreement”), whereby the Grantor granted the Administrative Agent a security interest in certain trademarks of the Grantor, including the trademarks and trademark applications listed on **Schedule A** attached hereto (the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 16, 2019 at Reel 6526, Frame 0045;

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest and all of its right, title and interest in the Trademark Collateral, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:


1. Release and Assignment. The Administrative Agent hereby discharges, terminates and releases its security interest in all of the Trademark Collateral, and the Administrative Agent hereby assigns and transfers to the Grantor, without recourse, all of the Administrative Agent’s right, title and interest in and to the Trademark Collateral and the related registrations and goodwill, effective as of the date set forth above.

2. Further Assurances. The Administrative Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantor’s sole cost and expense.
