DEED OF ASSIGNMENT

This Agreement is made in Courbevoie (France) on May 1st, 2022.

BETWEEN:

Assignor: TotalEnergies Holdings, a limited liability company organized and existing under the law of FRANCE, with office located at 2, place Jean Millier, La Défense 6, 92400 COURBEVOIE, FRANCE

and

Assignee: TotalEnergies SE, a *societas europaea* (se) organized and existing under the law of FRANCE, with office located at 2, place Jean Millier, La Défense 6, 92400 COURBEVOIE, FRANCE

WHEREAS:

- (A) For historical reasons Assignor holds titles of trademarks registrations listed in Appendix to this Agreement (the "**Trademarks**").
- (B) Assignor and Assignee have agreed that the said Trademarks shall be transferred to the Assignee which is its parent company and the registered owner of the group's trademarks worldwide.
- (C) Assignor is willing to assign full and absolute title to the Trademarks and all goodwill and right attaching to and deriving from them to Assignee, and Assignee is willing to accept such assignment

IT IS AGREED as follows:

1. Assignment

1.1. By this Agreement, and in consideration of the payment of 1 (one) €, the Assignor transfers to the Assignee:

- (i) all right, title and interest in and to the Trademarks, together with the goodwill attached to the Trademarks;
- (ii) the right to file all proceedings for infringement or for unfair competition occurring prior to or following the date on which this Agreement is executed.

This assignment shall also include the assignment of all the trademark licence agreements, if any.

1.2. This assignment is granted without exception or reservation and with no warranty other than warranties that the registration of the Trademarks exists on the date of execution of this Agreement.

2. Recordal of the agreement

The Assignee, or any third party duly empowered by the Assignee, shall carry out all the formalities required for the performance of this Agreement, in particular for making the assignment of the Trademarks enforceable against third parties. The Assignee shall bear the cost of these formalities.

3. Governing Law & Jurisdiction

This Agreement shall be governed by the laws of France. Any dispute arising as a result of the creation, interpretation or performance of this Agreement shall be submitted to the exclusive jurisdiction of the courts of Nanterre.
