**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated this 7<sup>th</sup> day of June, 2022 (this "Release") is made by Fifth Third Bank, National Association, with a place of business at 38 Fountain Square Plaza, Cincinnati, Ohio 43263 (the "Secured Party"), of an Intellectual Property Security Agreement dated as of October 1, 2003 and recorded on November 24, 2003 in the records of the United States Patent and Trademark Office Assignment Branch at Trademark Reel/Frame 2885/0857 (the "Security Agreement"), between Secured Party and Cold Jet, LLC (the "Debtor").
