RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of April 1, 2022 (this “Release”), is made by TC LENDING, LLC, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, the “Agent”) in favor of FASTBRIDGE LEARNING, LLC (the “Grantor”). All terms used but not otherwise defined herein have the meanings given to them in the A&R GSA.

WITNESSETH

WHEREAS, the Grantor, among others, and the Agent are parties to that certain Amended and Restated Guaranty and Security Agreement, dated as of August 25, 2017, as amended and restated as of June 22, 2018 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “A&R GSA”);

WHEREAS, pursuant to the A&R GSA, the Grantor executed the Trademark Security Agreement, dated as of August 23, 2019 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on August 23, 2019 at Reel/Frame No. 6728/0312, pursuant to which the Grantor granted and pledged to the Agent a continuing security interest in all of the Grantor’s right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including without limitation the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the A&R GSA and the Trademark Security Agreement.
