RELEASE OF TERM LOAN AND LC TRADEMARK SECURITY AGREEMENT

This RELEASE OF TERM LOAN AND LC TRADEMARK SECURITY AGREEMENT (this "Release") is made and effective as of June 6, 2022, and granted by WILMINGTON TRUST, NATIONAL ASSOCIATION, as successor administrative agent (in such capacity, the "Agent") under that certain Term Loan and LC Trademark Security Agreement, dated as of November 30, 2016 (the "Original Trademark Security Agreement"), made by Strike, LLC, a Texas limited liability company (the "Grantor"), in favor of the Agent, as amended by that certain Term Loan and LC Trademark Security Assignment Agreement, dated as of September 4, 2020 (the "Assignment Agreement"), by Bank of America, N.A., as the prior administrative agent, in favor of the Agent (as so amended and as further amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement"). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Trademark Security Agreement.

WHEREAS, the Original Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 005931, Frame 0722 on December 1, 2016,

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office at Reel 007045, Frame 0641 on September 4, 2020,

WHEREAS, the Grantor has requested that the Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Agent and the Secured Parties may have in the IP Collateral pursuant to the Trademark Security Agreement; and

WHEREAS, the Agent desires to terminate and release its security interest in the IP Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby states as follows:

1. Release of Security Interest. The Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (i) terminate the Trademark Security Agreement and terminate, release and discharge its security interests under the Trademark Security Agreement in, and reassigns to the Grantor, all of the Grantor's right, title and interest in and to the United States registered Trademarks and Trademarks for which United States applications are pending, including those set forth in Schedule A hereto (the "IP Collateral").

2. Filing of the Release. The Agent agrees to make filings with the United States Patent and Trademark Office and take further actions, in each case as reasonably requested by the Grantor and at the sole expense of the Grantor, to evidence the release and termination of the Agent's security interests in the IP Collateral.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and

construed in accordance with, the laws of the United States and the State of New York, without reference to its conflict of laws principles.


